

**PERRIS UNION HIGH SCHOOL DISTRICT
RESOLUTION NO. 17:23-24**

**RESOLUTION AUTHORIZING PIGGYBACKING FOR THE PURCHASE OF DSA
APPROVED RELOCATABLE CLASSROOMS FOR LIBERTY HIGH SCHOOL**

WHEREAS, the District wishes to purchase six (6) DSA Approved Relocatable Classrooms for use at Liberty High School in the amount of \$584,308.30 (“Contract Price”); and

WHEREAS, the Garvey School District (“Garvey”), conducted a competitive solicitation process for the purchase of DSA Approved Relocatable Buildings in accordance with Public Contract Code section 20111. Garvey awarded the contract (“Garvey Contract”) to Unified Modular Corporation, and authorized other California School districts, including the District, to participate in the Garvey Contract; and

WHEREAS, on May 18, 2023, the Garvey School District Board of Trustees awarded the Garvey Contract to Unified Modular Corporation ("Supplier") in accordance with all terms and conditions listed in the request for proposals; and

WHEREAS, California Public Contract Code section 20118 authorizes the Board to purchase DSA Approved Relocatable Buildings from Supplier under existing contracts, such as the Garvey Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases DSA Approved Relocatable Buildings on the same terms and conditions as set forth in the underlying contract;

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of DSA Approved Relocatable Classrooms from the Supplier under the same terms and conditions as the Garvey Contract.
3. The Board has determined that piggybacking on the Garvey Contract for the purchase of DSA Approved Relocatable Classrooms is in the best interests of the District.
4. The Board has determined that minor installation costs constituting only up to 15% of the Contract Price, to be provided by Supplier upon delivery, are incidental to the total amount to be paid by the District under the Garvey Contract, which is intended for the purchase of six (6) DSA approved relocatable classrooms for Liberty High School.
5. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the Garvey Contract between Garvey School District and Unified Modular Corporation and, pursuant to the "piggybacking" procedures of Public Contract Code section

20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
