

**PERRIS UNION HIGH SCHOOL DISTRICT  
RESOLUTION NO. 19:21-22**

**RESOLUTION AUTHORIZING PIGGYBACKING FOR PURCHASE OF SCHOOL  
FURNISHINGS, OFFICE FURNITURE AND ACCESSORIES**

**WHEREAS**, the District wishes to purchase various School Furnishings, Office Furniture and Accessories for use at District school sites in an estimated amount of \$815,000 (“Contract Price”); and

**WHEREAS**, the Arvin Unified School District (“Arvin USD”), conducted a competitive solicitation process for the purchase of School Furnishings, Office Furniture and Accessories in accordance with Public Contract Code section 20111. Arvin USD awarded the contract (“Arvin USD Contract”) to various low bidders, and authorized other California School districts, including the District, to participate in the Arvin USD Contract; and

**WHEREAS**, on November 13, 2018, the Arvin USD Board of Trustees awarded the Arvin USD Contract in part to Sierra School Equipment Company ("Supplier") in accordance with all terms and conditions listed in the request for proposals; and

**WHEREAS**, on September 15, 2021, the Arvin USD Board of Trustees extended the above referenced bid from November 13, 2021 through November 12, 2022, and is therefore still valid and enforceable; and

**WHEREAS**, California Public Contract Code section 20118 authorizes the Board to purchase various School Furnishings, Office Furniture and Accessories from Supplier under existing contracts, such as the Arvin USD Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases School Furnishings, Office Furniture and Accessories on the same terms and conditions as set forth in the underlying contract;

**NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:**

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of School Furnishings, Office Furniture and Accessories from the Supplier under the same terms and conditions as the Arvin USD Contract.
3. The Board has determined that piggybacking on the Arvin USD Contract for the purchase of the needed School Furnishings, Office Furniture and Accessories is in the best interests of the District.

4. The Board has determined that minor installation costs constituting only up to 15% of the Contract Price, to be provided by Supplier upon delivery, are incidental to the total amount to be paid by the District under the Arvin USD Contract, which is intended predominately for furnishing of District facilities.
  
5. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the Arvin USD Contract between Arvin USD and Sierra School Equipment Company and, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
