

**PERRIS UNION HIGH SCHOOL  
DISTRICT RESOLUTION NO. 39:22-23**

**RESOLUTION AUTHORIZING PIGGYBACKING FOR THE PURCHASE  
OF BREAD AND BAKERY PRODUCTS**

**WHEREAS**, the District wishes to purchase Bread and Bakery Products for the District's National School Lunch Program and School Breakfast Program; and

**WHEREAS**, the Hesperia Unified School District, ("Hesperia") conducted a competitive solicitation process for the purchase of fresh baked products in accordance with Education code section 38110. Hesperia awarded the contract ("Hesperia Contract") to the responsive, responsible supplier and authorized other public agencies, including the District, to participate in the Hesperia Contract; and

**WHEREAS**, on March 14, 2022, the Governing Board of the Hesperia Unified School District awarded the Contract to Galasso's Bakery ("Supplier") in accordance with all terms and conditions listed in the request for proposals and will be valid from July 1, 2023 through June 30, 2024; and

**WHEREAS**, California Public Contract Code section 20118 authorizes the Board to purchase fresh baked products from Supplier under existing contract, such as the Hesperia Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases fresh baked products on the same terms and conditions as set forth in the underlying bid.

**NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:**

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of fresh baked goods from the Supplier under the same terms and conditions as the Hesperia Contract.
3. The Board has determined that piggybacking on the Hesperia Contract is in the best interest of the District.
4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the Hesperia Contract between Hesperia Unified School District and Galasso's Bakery and, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
