WHEREAS, the Governing Board of the CALIFORNIA MILITARY ACADEMY ("Charter") has determined that it shall be necessary to reduce or discontinue the particular kinds of services of the Charter described herein as of the end of the 2020-2021 school year; and

WHEREAS, it shall be necessary at the end of the 2020-2021 school year to terminate the employment of certain certificated employees of the Charter as a result of this reduction or discontinuance of particular kinds of services; and

WHEREAS, the Governing Board has determined that it is in the best interest of the Charter that, as of the end of the 2020-2021 school year, the following particular kinds of service now being provided by certificated personnel of the Charter be reduced or discontinued:

WHEREAS, the Governing Board has found that the foregoing services to be reduced or discontinued constitute "particular kinds of service" and that statutory "layoff" procedures, including but not limited to those set forth in Education Code sections 44949 and 44955, do not apply to the Charter.

NOW, THEREFORE, BE IT RESOLVED by the Governing Board of the CALIFORNIA MILITARY INSTITUTE that, as of the end of the 2020-2021 school year, the above-identified particular kinds of service be and hereby are reduced.

BE IT FURTHER RESOLVED, that due to the reduction or discontinuance of particular kinds of service, the full-time equivalent of one (1.0) certificated employee of the Charter, as set forth above, shall be dismissed at the end of the 2020-2021 school year and not re-employed for the 2021-2022 school year; and

BE IT FURTHER RESOLVED, that the Superintendent (or Principal/Commandant) is directed to initiate and pursue any procedures necessary to effect this reduction or discontinuance of particular kinds of service, and to dismiss and not to reemploy the full-time equivalent of one

(1.0) certificated employee of this Charter because of said reduction and/or discontinuance of services, including but not limited to providing appropriate notices to each employee whose services shall be terminated by virtue of this action.
