FY17-18 DISTRICT AGREEMENT FOR GEOGRAPHIC RELATED SERVICES GST Service Agreement #17-071-C-001

This Service Agreement, made and entered into this 1st day of July, 2017, by and between HOLLISTER-POWELL & ASSOCIATES – GEOSPECTIVE TECHNOLOGIES™, hereinafter referred to as "GST", and the PERRIS UNION SCHOOL DISTRICT of Riverside County, hereinafter referred to as the "DISTRICT";

WITNESSETH:

1. GST agrees to provide services for the DISTRICT under this agreement as follows:

6. **GST DATA AND SOFTWARE:**

<u>Use</u>: If GST Geographic Data and/or Software is provided for any purpose(s) under this agreement, DISTRICT shall use GST Data and/or Software only for the sole purpose(s) of student address validation, transportation, tract map management, or GIS modeling, and not for any other purpose or use, unless first receiving written permission from GST to do so, or as otherwise authorized in this agreement.

Ownership: GST retains all right, title and interest, including all copyright and intellectual property rights, in and to, any GST Data and/or Software provided under this agreement, including and all copies thereof. GST Data is provided exclusively on a lease and/or license only basis for the duration of this agreement, and ownership of GST Data and/or Software is neither transferred to DISTRICT, nor should be construed nor implied to be transferred to DISTRICT, under this agreement. GST Data and/or Software ownership interest belongs exclusively to Hollister-Powell & Associates – GeoSpective TechnologiesTM and exists in perpetuity, and all corresponding terms of the agreement shall likewise exist in perpetuity. Such ownership shall include right of reproduction, distribution and/or sale to third parties and all copyrights, patents, licenses, or similar intellectual property rights resulting from the use and/or development of Data.

However, other than expressly set forth in the terms of this agreement, we do not make any promises and/or commitments about our service and/or product functions, content, reliability, availability, or general ability to meet your needs. We exclude all warranties other than those specifically referenced herewithin.

<u>Extent of Liability</u>: GST will not be responsible for financial losses or indirect, consequential, exemplary, or punitive damages to the extent permitted by law. GST limits it's total liability to the total amount you paid us for our services as outlined in this service agreement. Under no circumstances will GST be liable for any loss or damage outside our reasonable ability to predict, control, and/or foresee.

- 7. GEOGRAPHIC TERRITIORY: The GST Geographic Data and/or services that may be provided under this agreement will be limited to the sphere of influence of PERRIS UNION SCHOOL DISTRICT unless otherwise modified in writing to include additional territories, and/or as specified in an End User License Agreement for GST software, and/or any other mutually agreed upon binding agreement authorized by GST.
- 8. **DISCOUNTS**: GST guarantees DISTRICT discount prices for the following:
 - Custom mapping projects: A 20% discount on map labor.
 - Other Technical services: Master Plans, other related GIS tasks and consulting, and application development and other programming services shall apply a 25-30% discount on the total cost of each unique project. All discounts are based upon time and assigned hourly rate from the Billing Rate Schedule in #10.
- 9. <u>ADDITIONAL SERVICES</u>: DISTRICT may contract with GST for additional services not specifically described under "A. SCHOOL DISTRICT SERVICE PACKAGE", "B. GST WEB ADDMATCH© PACKAGE", or "C. GST TRACTMAP MANAGER© PACKAGE". Said services shall be <u>billed in addition to fees specified in "3. PAYMENT" and "5. NOT TO EXCEED</u>", and based upon and for the hours worked and the rate and fee schedule listed below. Discounts will be offered on projects of extended duration. Discount applied is dependent upon project duration.

- 13. <u>HOLD HARMLESS</u>: The parties hereto, and each of them, do hereby mutually agree to indemnify, defend, save and hold harmless each other, their respective officers, agents, servants and employees, of and from any and all liability, claims, demands, debts, suits, actions and causes of action, including wrongful death and reasonable attorneys fees for the defense thereof, arising out of or in any manner connected with the performance of any act or deed under or pursuant to the terms and provisions of this agreement by such indemnifying party, or its officers, agents, servants and employees.

This indemnification shall apply with equal force to any and all liabilities, claims, debts, damages, demands, suits, actions and causes of action related to actual or alleged infringement or violation

of any copyright, patent, license, trade secret or similar intellectual property rights by DISTRICT or subcontractor of DISTRICT.

- 16. **CHANGES:** This agreement may only be amended in writing by the mutual consent of the parties hereto.
- 17. **TERMINATION**: This agreement will NOT automatically renew. Any new term will require a new agreement to be signed by both parties prior to any services taking place. DISTRICT will provide GST with <u>written notice no less than sixty (60) days prior to the expiration of this agreement if DISTRICT, at its option, elects to NOT pursue a service agreement with GST for FY17-18. If such written notice is received, or if this agreement expires and is not superseded with a new mutually agreed upon agreement for GST services as outlined here within, the following termination conditions and terms apply:</u>

GST Geographic Data: (a) DISTRICT must cease use of any and all GST Geographic Data provided under this agreement; (b) DISTRICT must remove GST Geographic Data from any and all Database tables and storage devices, and destroy all copies of GST Geographic Data then in DISTRICT possession and/or control, (c) DISTRICT shall take such other actions as Hollister-Powell & Associates may reasonably request to ensure that no unlicensed and/or unauthorized usage of GST Geographic Data continues after the expiration of this agreement, and all copies of GST Geographic Data no longer exist in DISTRICT possession and/or control; (d) At the option of GST, DISTRICT shall sign and return a "Verification of Non-Use of Proprietary Data" form indicating DISTRICT has compiled with aforementioned termination terms and conditions related to GST Geographic Data.

GST Software and/or Saas (a) DISTRICT must cease use of any and all GST Software licensed under this agreement; (b) As applicable, DISTRICT must uninstall and/or remove GST Software from any and all computer storage devices, and destroy all copies of GST Software then in DISTRICT possession and/or control, (c) DISTRICT shall take such other actions as Hollister-Powell & Associates may reasonably request to ensure that no unlicensed or unauthorized use of GST Software continues after the expiration of this agreement, and as applicable, all copies of GST Software no longer exist in DISTRICT possession and/or control; (d) At the option of GST, DISTRICT shall sign and return a "Verification of Non-Use of Proprietary Software" form indicating DISTRICT has compiled with aforementioned termination terms and conditions related to GST Software
