

**PERRIS UNION HIGH SCHOOL DISTRICT  
RESOLUTION NO. 6:19-20**

**A RESOLUTION AUTHORIZING PIGGYBACKING FOR ACQUISITION OF  
MODULAR BUILDINGS**

**WHEREAS**, the District wishes to purchase modular buildings needed for use at District school sites; and

**WHEREAS**, the Garden Grove Unified School District ("GGUSD") conducted a competitive bidding process for the purchase of Modular Buildings in accordance with Education code section 38110. GGUSD awarded the contract ("GGUSD Contract") for Modular Buildings to the low bidder, and authorized other California School districts, including the District, to participate in the GGUSD Contract; and

**WHEREAS**, on September 1, 2019, the GGUSD Board of Trustees awarded the GGUSD Contract to Sean Khan Consulting Company, Inc., dba SKC Company ("Vendor") as the lowest responsive and responsible bidder and renewed the contract on August 20, 2019 for an additional year; and

**WHEREAS**, California Public Contract Code section 20118 authorizes the Board to purchase Modular Buildings from Vendor under existing contracts, such as the GGUSD Contract, without advertising for bids, if the Board determines it is in the best interests of the District, and the District purchases the Modular Buildings on the same terms and conditions as set forth in the underlying bid; and

**NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:**

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of Modular Buildings from the Vendor under the same terms and conditions as the GGUSD Contract.
3. The Board has determined that piggybacking on the GGUSD Contract is in the best interests of the District.
4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the GGUSD Contract between GGUSD and SKC Company, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
