FULL SERVICES DISTRICT AGREEMENT FOR GIS/DEMOGRAPHIC RELATED SERVICES

GST Service Agreement #24-071-C-001

This Service Agreement, made and entered into this 1st day of July, 2024, by and between GEOSPECTIVE TECHNOLOGIES™, hereinafter referred to as "GST", and the PERRIS UNION HIGH SCHOOL DISTRICT of Riverside County, hereinafter referred to as the "DISTRICT";

WITNESSETH:

1. GST agrees to provide services for the DISTRICT under this agreement as follows:

A. **ANNUAL SCHOOL DISTRICT SERVICE PACKAGE (required)** consisting of:

1. **GST GeoSense© Street Address Validation Data** for use in School District Student System address verification:
 - District Student System type identified as **Infinite Campus©**
 - Requires access to designated student datasets/fields
 - Geographic Data can be nightly exported into student address validation database tables or as needed

4. **LATE PAYMENTS:** GST, at its option, may impose a late fee for balances outstanding more than thirty (30) days from the date specified on any invoice. If a late payment is assessed, it will be charged at 1.75% per month (21% annum.).
5. **NOT TO EXCEED:** In no event shall the total estimated amount paid under this agreement exceed the sum of **\$28,100.00, plus any additional work and/or options requested and authorized by DISTRICT** as per above payment schedule(s) and/or based upon the Billing Rate Schedule (including any applicable discounts as specified here within). **Additional Work Cost not-to-exceed \$5,000.00.**
6. **GST DATA AND SOFTWARE:**

Use: If GST Geographic Data and/or Software is provided for any purpose(s) under this agreement, DISTRICT shall use GST Data and/or Software only for the sole purpose(s) of student address validation, transportation, tract map management, or GIS modeling, and not for any other purpose or use, unless first receiving written permission from GST to do so, or as otherwise authorized in this agreement.

Ownership: GST retains all right, title and interest, including all copyright and intellectual property rights, in and to, any GST Data and/or Software provided under this agreement, including and all copies thereof. GST Data is provided exclusively on a lease and/or license only basis for the duration of this agreement and ownership of GST Data and/or Software is neither transferred to DISTRICT, nor should be construed nor implied to be transferred to DISTRICT, under this agreement. GST Data and/or Software ownership interest belongs exclusively to GeoSpective Technologies™ and exists in perpetuity, and all corresponding terms of the agreement shall likewise exist in perpetuity. Such ownership shall include right of reproduction, distribution and/or sale to third parties and all copyrights, patents, licenses, or similar intellectual property rights resulting from the use and/or development of Data.

Limitations of Use: DISTRICT may not loan, rent, lease, sublicense, distribute or otherwise transfer all or any portion of GST Data and/or Software to third parties without first receiving GST's written permission to do so. GST maintains the right to determine whether or not to provide its data to any third-party vendor, and assumes no obligation to do so within this agreement with DISTRICT. If such permission is granted to a third-party vendor by GST, all third-party vendors working on behalf of DISTRICT shall sign a GST District Third Party Data Usage Agreement specifying terms for use of GST Data. Use of GST Data and/or Software should be restricted within, by, and for the PERRIS UNION HIGH SCHOOL DISTRICT unless otherwise expressly authorized in writing by GST. DISTRICT may not copy GST Data and/or Software except as expressly set forth in this agreement, and any copies that DISTRICT is permitted to make pursuant to this agreement must contain the GST copyright, patent and other intellectual property markings that appear on or in the Data and/or Software. DISTRICT may not modify, adapt, or translate the GST Data and/or Software. For purposes of security, vendor utilization must be registered and approved by GeoSpective Technologies™. DISTRICT shall be held liable for any intentional misuse of GST Data and/or Software, which is within the reasonable scope of the DISTRICT to administer and monitor.

Reverse Engineering: Except and to the limited extent as may be otherwise specifically provided by applicable law, DISTRICT may not reverse engineer, decompile, disassemble or otherwise attempt to discover the source code, underlying ideas, underlying user interface techniques or algorithms of GST Data and/or Software by any means whatsoever, directly or indirectly, or disclose any of the foregoing, except to the extent DISTRICT may be expressly permitted to decompile under applicable law, if it is essential to do so in order to achieve operability of the Data and/or Software with another software program, and DISTRICT has first requested GeoSpective Technologies™ to provide the information necessary to achieve such operability and GeoSpective Technologies™ has not made such information available. DISTRICT shall not

use GST Data and/or Software to develop any data, software or other technology having the same primary function as the GST Data and/or Software, including but not limited to using the GST Data and/or Software in any development or test procedure that seeks to develop like data and/or software or other technology, or to determine if such software or other technology performs in a similar manner as the Software.

License Agreements: DISTRICT shall abide by all conditions and terms as set forth in any corresponding Software EULA (End User License Agreement) for software licensed through this agreement (Refer to corresponding Software EULA for details).

General Warranties and Disclaimers: In accordance with the terms of this service agreement, GST will provide various services and/or supporting software and/or data products based upon GST's reasonable level of experience, expertise, skill and responsiveness to meet DISTRICT's needs. However, other than expressly set forth in the terms of this agreement, we do not make any promises and/or commitments about our service and/or product functions, content, reliability, availability, or general ability to meet your needs. We exclude all warranties other than those specifically referenced here within.

Extent of Liability: GST will not be responsible for financial losses or indirect, consequential, exemplary, or punitive damages to the extent permitted by law. GST limits its total liability to the total amount you paid us for our services as outlined in this service agreement. Under no circumstances will GST be liable for any loss or damage outside our reasonable ability to predict, control, and/or foresee.

7. **GEOGRAPHIC TERRITORY:** The GST Geographic Data and/or services that may be provided under this agreement will be limited to the sphere of influence of PERRIS UNION HIGH SCHOOL DISTRICT unless otherwise modified in writing to include additional territories, and/or as specified in an End User License Agreement for GST software, and/or any other mutually agreed upon binding agreement authorized by GST.
8. **DISCOUNTS:** GST guarantees DISTRICT discount prices for the following:
 - o Custom mapping projects: A 35% discount on map labor.
 - o Other Technical services: Master Plans, other related GIS tasks and consulting, and application development and other programming services shall apply a 25-30% discount on the total cost of each unique project. All discounts are based upon time and assigned hourly rate from the Billing Rate Schedule in #11.
9. **ADDITIONAL SERVICES:** DISTRICT may contract with GST for additional services not specifically described under "A. SCHOOL DISTRICT SERVICE PACKAGE or "B. GST TRACTMAP MANAGER® PACKAGE". Said services shall be billed in addition to fees specified in "3. PAYMENT" and "5. NOT TO EXCEED", and based upon and for the hours worked and the rate and fee schedule listed below. Discounts will be offered on projects of extended duration. Discount applied is dependent upon project duration.

11. **DEPENDENCY TASKS:** GST assumes no responsibility or liability for project delays, or failure to include any information or Data, or complete a required task and/or project, due to delays or failure on the part of DISTRICT, including its agents and/or other consultants, to properly provide necessary District information and/or perform necessary dependency tasks, which results in lack of reasonable and sufficient time for GST to properly process and/or prepare information, and/or complete a required task as defined in this agreement.
12. **INDEPENDENT CONTRACTOR:** GST, while engaged in the performance of this agreement, is an independent contractor, and is not an officer, agent or employee of DISTRICT.
13. **CONFIDENTIALITY:** All forms of communications and information that transpire between GST and DISTRICT are considered strictly confidential. All data related to district personnel or student data that reside on GST servers is considered extremely confidential. The Parties understand and agree that as part of the work that GST will provide pursuant to this Agreement, GST is expected to receive records or record systems from or on behalf of DISTRICT that (a) are subject to FERPA or (b) contain personally identifiable information from "Education Records" as defined by and subject to FERPA (collectively, FERPA Records) namely: Student ID, Name, Address, Grade, Age, School of Attendance, etc. FERPA Records include all data in any form whatsoever, including electronic or written form. All FERPA Records received by GST will remain the exclusive property of DISTRICT. GST acknowledges that student data is protected by the Family Educational Rights and Privacy Act Regulations 34 CFR Part 99 (FERPA) and will take all appropriate measures to protect and maintain the confidentiality of said records according to these regulations.
14. **HOLD HARMLESS:** The parties hereto, and each of them, do hereby mutually agree to indemnify, defend, save and hold harmless each other, their respective officers, agents, servants and employees, of and from any and all liability, claims, demands, debts, suits, actions and causes of action, including wrongful death and reasonable attorney's fees for the defense thereof, arising out of or in any manner connected with the performance of any act or deed under or pursuant to the terms and provisions of this agreement by such indemnifying party, or its officers, agents, servants and employees.
This indemnification shall apply with equal force to any and all liabilities, claims, debts, damages, demands, suits, actions and causes of action related to actual or alleged infringement or violation of any copyright, patent, license, trade secret or similar intellectual property rights by DISTRICT or subcontractor of DISTRICT.
15. **LIMITATION OF LIABILITY:** To the maximum extent permitted by applicable law even if a remedy fails its essential purpose, in no event shall GeoSpective Technologies™ be liable for any special, incidental, direct, indirect or consequential damages whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or any other pecuniary loss) arising out of the use of or inability to use the Software and/or services under this Service Agreement, or the provision of or failure to provide support services, even if GeoSpective Technologies™ has been advised of the possibility of such damages. In any case, GeoSpective Technologies™ liability under any provision of this District Agreement for Geographic Services shall be limited to the amount actually paid by DISTRICT for services under this Service Agreement.
16. **INTERNET/TRANSMISSION DISCLAIMER:** GST does not and cannot control the flow of data over the Internet or the integrity of the Internet (the global system of interconnected computer networks). Therefore, GST disclaims all liability for loss of data, corruption of data, or inability to provide Services, as a result of disruptions, slowdowns, breakdowns, or other technical issues affecting the Internet.
17. **ACCEPTANCE:** This service agreement is considered accepted in its entirety by both parties when DISTRICT issues a Purchase Order and/or Contract for GST Services based upon the articles here within, thus binding both parties to the terms and conditions outlined here within this service agreement.
18. **CHANGES:** This agreement may only be amended in writing by the mutual consent of the parties hereto.
19. **TERMINATION:** This agreement will NOT automatically renew. Any new term will require a new agreement to be signed by both parties prior to any services taking place. DISTRICT will provide GST with written notice

no less than sixty (60) days prior to the expiration of this agreement if DISTRICT, at its option, elects to NOT pursue a service agreement with GST for FY24-25. If such written notice is received, or if this agreement expires and is not superseded with a new mutually agreed upon agreement for GST services as outlined here within, the following termination conditions and terms apply:

GST Geographic Data: (a) DISTRICT must cease use of any and all GST Geographic Data provided under this agreement; (b) DISTRICT must remove GST Geographic Data from any and all Database tables and storage devices, and destroy all copies of GST Geographic Data then in DISTRICT possession and/or control, (c) DISTRICT shall take such other actions as GeoSpective Technologies™ may reasonably request to ensure that no unlicensed and/or unauthorized usage of GST Geographic Data continues after the expiration of this agreement, and all copies of GST Geographic Data no longer exist in DISTRICT possession and/or control; (d) At the option of GST, DISTRICT shall sign and return a "Verification of Non-Use of Proprietary Data" form indicating DISTRICT has complied with aforementioned termination terms and conditions related to GST Geographic Data.

GST Software and/or SaaS (a) DISTRICT must cease use of any and all GST Software licensed under this agreement; (b) As applicable, DISTRICT must uninstall and/or remove GST Software from any and all computer storage devices, and destroy all copies of GST Software then in DISTRICT possession and/or control, (c) DISTRICT shall take such other actions as GeoSpective Technologies™ may reasonably request to ensure that no unlicensed or unauthorized use of GST Software continues after the expiration of this agreement, and as applicable, all copies of GST Software no longer exist in DISTRICT possession and/or control; (d) At the option of GST, DISTRICT shall sign and return a "Verification of Non-Use of Proprietary Software" form indicating DISTRICT has complied with aforementioned termination terms and conditions related to GST Software.
