9.2 District Update by the Superintendent

The Superintendent reported on the following:

- Superintendent Bennett introduced Kirk Skorpanich, Assistant Superintendent of Human Resources, to introduce the following District Employee of the Year winners:

 - Dr. Erika Tejada - Principal of the Year
- The second semester started off well, and students seemed excited to be back on campus.
- Student of the Month was on January 11th. Four students were recognized for their hard work.
- Lastly, Superintendent Bennett shared that Paloma Valley High School earned the College Board's AP[®] Computer Science Female Diversity Award for expanding young women's access to AP Computer Science A and AP Computer Science Principles. This award acknowledged 1,105 schools for their work toward equal gender representation during the 2021-22 school year. Paloma Valley is one of only 64 schools to be recognized for achieving this important result in both courses.

CSEA President Nathanael Nash shared the following statements:

- "CSEA is grateful that the District has agreed to send two members from each school site to the 26th Annual CSEA Paraeducator Conference. Being a paraeducator myself, it's great training, and I have had the opportunity to attend the conference twice."

- "I look forward to working with everybody and continuing the relationship that has grown and fostered over the years."

9.5 PSEA President Jason Miller

PSEA President Jason Miller shared the following statements:

- "Congratulations to the Employee of the Year winners; Kevin Cauchon, Gabrielle Ladner-Mejia, Will Warren, James Heckman, Luis Robles, and Mark Synnott."
- "Regarding the Computer Science award. If you know Mike Wilson, that guy is amazing. He runs an amazing computer science program."
- "Recently, we had an issue come up where non-PSEA members were teaching classes that were PSEA member classes. This has been fixed. I bring this up to highlight a process unique to PSEA, where the administration listens to the union and solves problems quickly. It isn't easy to describe because some districts do not have a substantial relationship with their unions. Primarily because in some districts, not all, but in some places, there's an attitude of administrators being the bosses, the employees being just employees, and somewhere in between is the union. In some districts, that is the only relationship between the administration and the union."
- "Here we have a commitment that the administration will fix problems where they exist and that there's a lot of follow through. The administrators don't often say they will try and look into something just to get the union to shut up. Much of the administration follows through with their commitment to solutions. For our part, PSEA does not rush to draw a line in the sand or file something like an unfair labor practice or grievance. For PSEA, that is the last resort. How many here have been in an unfair labor practice hearing, a grievance hearing, or mediation? I suspect not many, maybe a few. It is easier and less stressful to sit down and hammer out solutions rather than go through a long, drawn-out, and costly process. I'm not saying PSEA will not file these things if it comes to that, but quite frankly, I cannot remember a time in recent memory that it has come to that. So if I ever do bring a serious issue up here or we do file some complaint, I know that we would have tried to resolve it with the Cabinet first, and then it must be a pretty serious problem."
- "We were able to fix the issue of the non-PSEA workers teaching PSEA classes that were favorable to both PSEA and the District. Solutions that work for both sides are always the best. Contrary to popular opinion, you can sometimes have your cake and eat it too. A win-win solution is one that we should look for if they exist for a particular issue. This only works if administrators are committed to trying to fix the problem. PSEA is committed to fixing problems instead of just filing complaints or starting fires. Thank you for the time to speak."

9.6 Comments by the Board of Trustees

Trustee Garcia congratulated the Employee of the Year winners. In addition, he addressed Mr. Nash, indicating he would like to connect, and looks forward to working with him. He also thanked Mr. Miller for his comments and was glad to hear the unions are being successful because it is all about the kids.

Trustee Campos thanked the Employee of the Year winners. He addressed Mr. Nash, stating that he was excited to see him grow throughout his presidency. He also thanked Mr. Miller for all that he does for PSEA. Trustee Campos shared that when he ran for the Board, his goal was to listen to what people had to say, and if issues needed to be resolved, he would try his best to do that. The positive things are always great, but the concerns need to be heard to move forward and make the right decisions. Hopefully, the Board will take all into consideration so that problems can get resolved. He reiterated what Trustee Garcia said regarding making sure that it benefits the students first and the staff as well.

Trustee Vallejo shared her appreciation for the transparency of Mr. Nash and Mr. Miller. She also noted that it's difficult at times to work for a school district and wants staff to know that the Board welcomes any concerns they might have.

Trustee Nelissen congratulated the Employee of the Year winners. He encouraged Mr. Nash, stating that he did a great job. He thanked Mr. Miller for updating the Board monthly on PSEA. Lastly, Trustee Nelissen welcomed everyone back from break and wished everyone a great second semester.

Trustee Stafford welcomed everyone back from break. He stated that his commitment as board president is to make a difference, listen to all sides, ask questions, and know what is happening in the District.
