The Board of Trustees presented all of the district's Student Representatives with certificates of appreciation for their contributions to the Board and community.

9.4 PSEA President Jason Miller

PSEA President Jason Miller shared the following statement:

"Happy teacher appreciation week. I don't know about you, but these student videos, over the last few years, these student presenters, they've really upped their game. They have just been, some of them have been quite moving. I had the opportunity to spend some time at Perris Lake High School, and they're right; they knew my name. One of the essential functions of any union is to represent members. While this can come in many forms, I wanted to take a moment to impart some of PSEA's perspectives on the topic of representation. I'm talking about direct representation, whether some meeting between an employer and an employee, and they literally ask for a representative. The actual language from our collective bargaining agreement is "If any conference between any district administrator and a unit member is called for the purpose of, or becomes an investigative interview, which a unit member reasonably believes may lead to discipline, the unit member shall have the right, upon request, to have an association representative present. The administrator shall either honor the request or discontinue the interview". This is standard language in keeping with representation criteria established by Weingarten. For those who don't know, Weingarten was a court case in the 1970s that established the criteria for a representative's presence at a meeting. So then, I would like to share a few points on PSEA's behalf with this in mind. When wanting a representative, a member has to ask for a representative for a meeting; however, PUHSD is sometimes gracious enough to ask the member if they need a

representative, but they don't have to do that. Also, members have a right to representatives for meetings that would reasonably be seen as disciplinary. Although occasionally, representatives have been in attendance at non-disciplinary meetings. However, having a representative in a non-disciplinary meeting is not a right that employees necessarily have. Sometimes, we have members request a specific representative. To the degree reasonable or feasible, PSEA supports a member having the representative of their choice. However, we also recognize, and it has been pretty well established by PERB, that an employee does not necessarily have the right to a representative of their choice. We also believe that only PSEA-elected or CTA representatives can represent PSEA members in this district. There's a lot of facets that go into representation. I've been doing this since 2008. I have represented billions of people; that is hyperbole. But the ones that I've spoken about today are some basic concepts that I wanted to highlight for you. Since there have been some comments at previous board meetings about when and who can represent people, I want to set the record straight on where we're at with all those concepts. Thank you for this time to speak."

9.5 CSEA President Helen Stimach

CSEA President Helen Stimach shared the following statement:

"Good evening, President Garcia and members of the Board, Superintendent, Mr. Bennett, and Cabinet. First, I'd like to apologize for having left before the end of the board meeting last month. I usually stayed at the end. But as it so happened, what good information was shared. After listening to the recording, I was pleased to hear that Ms. Martin is looking forward to having more positions added to the classified bargaining unit for workability and work-based learning opportunities. Even with the budget woes and with district financial hardships, finding a light in the tunnel to bring services for our students to new positions is of great importance and should be looked at more closely to find the right fit and purpose.

At the last meeting, Mr. Stafford mentioned cross-training and providing equity in extra duty for classified employees. I take this message seriously and want to explore opportunities to work closely with Mr. Skorpanich to make our plan viable so that cross-training and equity are realized for all classified employees. Thank you for bringing this to light so that we can work collaboratively for solutions.

On May 21st, the CRC, Classified Relationship Council, will meet again based on the board's feedback from the last board meeting and recent concerns from some sites. We plan to discuss in greater detail the sub-coverage MOU that is now in effect. We want to stay on top of this and will keep you informed of any future developments.

Next week is Classified Employees Week. We will appreciate our members in a small way since we are well over 550 members. During this week, we will also collaborate with the district in the Ace Appreciation Classified Employees Program. School administrators and board members are invited to job shadow our classified employees for a day. When a principal, superintendent, or board member spends a day working alongside classified employees, it helps them understand the essential work that we do every day. Administrators will roll up their sleeves to serve meals in the cafeteria, do the groundwork on campus, provide

security to our students, assist paraeducators in the classroom, and much more. It's a real-life experience that promotes understanding and appreciation of classified employees.

As the secretary in DEI, I was given the opportunity to attend my first RCOE Excellence with Equity Conference last year. Early conference registration is now being accepted for the 2024 conference, to be held in Palm Springs on September 19th and 20th. I recall that the board suggested, after the last conference, to include more classified employees to represent our district. I would like to offer a suggestion that members of my executive committee, my executive board negotiating team and current members of the equity team be considered to participate. I'm not sure who or how the selection process works and if money is available, but if possible, this invaluable information would be beneficial to my team, and we would appreciate any consideration given to us to attend.

Finally, I'd like to recognize Mr. Bennett for his 31 years of service with Perris Union. I know there will be many celebrations and recognition events, but I'd like to take this opportunity to acknowledge Grant for all the wonderful things he has done for our classified employees. Grant is always on the front lines. If he sees a piece of paper on a campus ground, he picks it up and doesn't wait for someone else to do it. I've seen him on one knee, helping a classified employee with a difficult math assignment that she needed for school that night. That employee has now gone on to become a teacher in another district. His humor is infectious, and his Three Trees math problem is a classic quick quip. He is a superintendent for all. So there's no wonder why super isn't part of his title. There are so many good things to say about Grant. We all don't want to be here all night. Time will be on his side in the months to come. Grant, please accept this little pocket watch as a token of our appreciation. It reads CSEA Chapter 469. Thank you for 31 Years of Leadership Retirement 2024. Thank you all for your continued support, direction, and comments on how to make classified employees are represented in all areas and very senior. Thank you."

9.6 Comments by the Board of Trustees

Trustee Nelissen shared that he attended the AVID graduation in Ontario, and it was great to see all the schools represented. He was also impressed with the number of PUHSD students that were recognized. He wished everyone a great end of the school year and congratulated all graduating seniors.

Trustee Vallejo thanked everyone who attended tonight's meeting, noting that it is a bit intimidating to speak before the Board. She encouraged those who spoke that the Board was listening. Trustee Vallejo also voiced her support of DEI and the DEI department. She has requested a report from Mr. Bennett outlining exactly what DEI is and what the department has accomplished this year.

Trustee Stafford thanked the student representatives for all the work they've done all year, along with staff and other students who have helped them behind the scenes. He stated he looked forward to the graduation and wished everyone a great summer. He also acknowledged those who are retiring and congratulated them. Lastly, Trustee Stafford thanked all of the workers throughout the District.

Trustee Campos also thanked the teachers and classified staff for all their work this year. In addition, he

thanked Jason Miller for his leadership and transparency. Mr. Campos spoke on Trustee Vallejo's comments in that it is very important that everyone speaks out and is heard. Anthony Noriega shared the following statement.

"My name is Anthony Noriega. I'm the district director for the League of United Latin American Citizens in the Inland Empire. Today, I address you with a heavy heart, reflecting the deep concerns echoing through our community and school district. The decision to defund the Diversity, Equity and Inclusion department has left a lasting, troubling impact that cannot be ignored. Your vote cast a dark shadow over each one of you. A shadow that will linger on you not only today, but also tomorrow and certainly on Election Day. Groups with agendas, like yours, introduce mental programs promoting diversity, falsely claiming that discrimination is a relic policy, claiming that these actions seek to silence the voice of minority communities, denying the reality of ongoing challenges. In your rush to dismantle the program, you ignore the pleas of the community. Can we ask you to reconsider? It is disheartening to see this council yield to right wing ideologies. Councilman. Compos, I address you directly as you have been particularly vocal in promoting policy, right? A far right ideology. You disseminate your lies, rumors, innuendos and hate throughout the district and beyond. Your actions have not gone unnoticed. The dark cloud looming over your head will follow you to Election Day in November. Councilwoman Vallejo, thank you for standing up for our community. Gracias."

Rocco Nelms shared the following statement.

"Good evening. Tonight I speak urgently about a critical issue facing our educational community here in our district. Budget cuts to Diversity, Equity and Inclusion initiatives undermine our commitment to equality and risk marginalizing vulnerable groups. On top of that, laying off wellness centers, care teams, threatening essential mental health support and increasing stress and academic struggles and students is just not okay in selecting a new superintendent. We must prioritize not only qualifications, but also a commitment to human rights and LGBTQ inclusivity. As an LGBTQ student, I wish to see somebody who will be able to fight for me and will be hearing what I have to say. And lastly, I'd like to address Steve Campos. Mr. Campos, I was researching on Twitter to find a better understanding of why we are still continuing to fight for common sense initiatives here in our district. And when I stumbled across your Twitter account, I'm sorry to say this, all I could see was disrespect and I was appalled. No board member at a school district should be displaying hateful commentary nonetheless on social media. To end these decisions deeply impact our community's well-being and educational experience. Thank you."

Carolyn Murray shared the following statement.

"The California Department of Education required that Perris Union High School District to develop a solution for the significant disproportionality of Hispanics with disabilities suspensions in the 2022-23 school year. The solution adopted by the district was to establish a wellness program, along with support and training from the Director of Diversity, Equity and Inclusion. The district now ending the second year is to be monitored for three years. The solution was an overwhelming success, with 29% reduction in A1 and A2 suspension and 55.8% reduction in drug related suspensions. To the dismay of teachers, staff and students, on March 5th, the Wellness Program staff, along with the DEI director, were laid off. The rationale given was budgetary, which was

totally without merit. First of all, there was a remaining year of financial support for the DEI director. She wrote and recently submitted and received \$7.3 million to support the wellness team. Secondly, the majority of the existing board, which is different from the board that established the program, has shown a disdain for DEI, which echoes a right wing agenda that is sweeping the nation. Why should school districts have DEI programs? One, to promote equity to foster inclusion. Three, to prepare students for a diverse world. Four, to reduce discrimination and bias. Five, to improve academic outcomes. Overall, DEI programs play a vital role in creating more inclusive, equitable, and supportive learning environments that benefit students, educators, and the community as a whole. There are several reasons why some people dislike DEI. One is perceived threat to the status quo. Another one is misunderstanding, a misconception that DEI has preferential treatment for certain groups. That's not true. It has fairness and equality for all. Another one is fear of change. Third one is political ideological opposition, which reject the idea of systemic oppression, or believe that efforts to promote diversity and inclusion are unnecessary. Lastly, personal bias and prejudice that just different people are seen as less than each of the four board members who voted to eliminate DEI should ask himself which of these five descriptions fit me, and how does the profile align with the oath that they took to educate our children? Renew the DEI directors position and the DEI program.”

Myrtle Foster shared the following statement.

“Good evening to the Board of Trustees, the Superintendent and to the Cabinet. I respectfully ask you to please reconsider the budget to include the DEI funding. You have until July to make that final decision. I am a former educator, and I was always assigned to a low performing school, and I always received the support and the support of funds and services that I needed to help raise levels for children. They always did the most cutting. They did not cut close to the classroom or close to the school itself, but they found other ways to cut funding in order for the children to receive the help that they needed. There's going to be a tomorrow, and many of my students, I was in the business for 40 years. They call back and they say, I remember when I received this service, I remember when you helped me to do this or that, and they are productive citizens. And I'm just asking you, please reconsider. Our children need this extra help. Give it to them.”




