9.2 District Update by the Superintendent

ORAL REPORTS (cont.)

Superintendent Araux shared several updates and reflections:

- Superintendent Araux introduced Mr. Alfredo Andrade as the new Chief Human Resources Officer.
- Dr. Araux expressed his gratitude for the opportunity to participate in the recent senior mock interviews at Perris High School, as well as the recognition of Student of the Month, which he found inspiring.
- Superintendent Araux recently attended a Unified Sports Soccer game at Paloma Valley High School, celebrating student collaboration. He highlighted the strong relationships and collaborative leadership with district associations.
- Superintendent Araux expressed appreciation for the support of the business department in proactively addressing financial matters, including implementing a system for medical billing reimbursement to ensure continued services for students and avoid staff layoffs.
- Superintendent Araux also spoke about attending the California Association of Black Educators
 Conference, where he gained insights for actionable changes in the District. He also praised CMI for
 improving English Learner (EL) reclassifications and efforts to help students achieve measurable
 academic success.
- Dr. Araux acknowledged Trustee Nelissen for his years of service, presenting him with an appreciation plaque. He also congratulated Ms. Vallejo on her election as Perris City Councilwoman. He thanked her for her years as a board member, also presenting her with a plaque for her service. Trustee Garcia was presented with a plaque in recognition of his service as the 2024 Board President.
- Superintendent Araux emphasized the District's ongoing commitment to student success and community collaboration.

CSEA President Helen Stimach shared the following statement.

ORAL REPORTS (cont.)

"Good Evening , President Garcia, Members of the Board, Superintendent Dr. Araux, and Cabinet. Where has this year gone? We are already getting ready for the holidays, and our students and educators are ready for some time away. As you can see from this evening's agenda, our negotiation team worked tirelessly with the District to bring forth six MOU's for ratification. The seniority MOU brings us in line with many districts on how we determine seniority by date of hire and not hours. This change will be a huge benefit and help to our small payroll department. The MOU on re-evaluating substitute coverage, while beneficial for a short period, is no longer viable and an alternative for district employee cost savings. Hopefullyfully, the Para Coverage MOU will help when RSP paras are asked to help in SH or SC positions due to absences. Although not the best answer for the employee absentee rate, at least our students do not go without the very needed support that these positions cover. Sun-setting the Spark Hire, the one-way interview system, was another cost-saving for the District. Group 1 of job description revisions is a huge undertaking. Last year, an MOU envisioned the process to take two years to complete, and this is just the first group of job description revisions presented to the Board. While preparing for this evening, I noticed that one of the MOUs on discipline had been pulled from the agenda. I hope to receive feedback on this item as we expedited the process to get to the Board tonight, and I would like to hear what the problem was with this MOU.

We still have much more work to do before we can enjoy the holidays. We still have to complete the re-openers for 2024-25 on Articles 9 Hours and Overtime and Article 10 Pay and Allowances. We will have elections for our executive board and negotiation teams next month which means even more change on the horizon.

We are looking ahead to the recent new additions to staffing at the top levels in our District and the ones coming soon. At Special Education, classified and administration alike are anxious to spread our wings into some new (old) facilities on the backside of the PALS campus and to bring services together for both SPED and Pupil Services to benefit our parents and students. Since coming to the SPED department in June, it's been rough not to unpack but to wait and wonder when the impending changes would happen. From a moral perspective, it's great to know something good is finally happening. Space for PALS and SPED has been much needed, and all staff look forward to transitions. We only hope that the District is mindful of bringing groups under one umbrella so that amenities for staff are not overlooked. Safety and security concerns are paramount not just for staff but for our students as well. We hope that monies can be allocated to support security at our campus. We will also need additional custodial services, which should not be overlooked. Although restrooms, parking, enclosed offices, lunchroom accommodations, water, and copiers may not be the first consideration while modifying existing buildings, this is our second home, and sometimes we spend more time here than we do with our families. We hope that the line of communication is open and that at some point in the process. our ideas and suggestions are included in discussions and considerations on what is best for all educators so that we can serve the public with the most efficiency, accessibility, and accountability. As monies are afforded in the most needed areas, I'd like to remind the Board that we still lack the extra five floater paraeducator positions. We hope that future money may be allocated to support the work these very important positions fulfill in our district.

I trust that under Dr. Araux's guidance, and in fulfilling the promise of meeting the goals and objectives and his vision and mission for Perris Union High School District, we will become a well-oiled machine, operating at full capacity, with transparency, honesty, and integrity.

Dianna Johnston, a community member, made the following statement:

"First of all, I'm not impressed. I'm just going to read my email already written to this district per a complaint and my response. I appreciate the response, and I'm grateful and hopeful for a proper investigation into all concerns on this matter. It has been a very difficult situation in more ways than one, as I discussed with Ms. Tejeda today, who is here, I'm highly concerned for all students and athletes involved and hope by now, all parents have been notified as this has been eating at me as not only a brand new parent to this site. I hoped that my child would be welcomed into a much-needed restart. But as a longtime educator, it's all very disturbing. The effect it had on my child's self-esteem, confidence, and mental health these past two months has now been unraveled as to where his explosiveness and depression escalated from. It hurts my heart, and I only hope all student-athletes know they can speak up and not fear retaliation or intimidation. And that this would not be the culture of what he was so hopeful was going to be his best swim season yet. My son has been very excited to push himself this winter to drop the times needed to get into the level he knows he needs to get back to talking to college swim programs. I had wondered why he had totally given up on those dreams and goals and now decided college sports were no longer for him. A complete turnaround from even the beginning of this August. He does have case managers and counselors who have followed him. I definitely want to see this deeply delved into, even his start at Liberty High School. The major missteps around his scheduling, repeated mistakes of blatantly ignoring my concerns, and many requests for calls and meetings are all adding up to be absolutely absurd. Why has all involved allowed a child to have to experience all of this. especially when all involved are fully aware of his already difficult reason for moving from Hemet to Liberty? Thank you for your time and I'll be looking forward to hearing the results and conclusions found. Have a good evening."

Jonathan Belloso, a community member, made the following statement:

"Hello, board. Once again, I'm here for accountability and transparency. So, as I begin, let me just extend my sincere sympathies and congratulations to you for finishing your career here with the Board, David Nelissen. I, too, also felt the sting of defeat. But hey, the cool thing about losing is now you can say whatever you want. So, with that being said, and with the little time I have left, I just really want to bring attention to a couple of things. Unfortunately, Jason Miller, PSEA President, is not here, but have you heard the buzz around town? It seems to be that there's a little bit of a controversy. That controversy being that what originally was a cap of \$5,500 for a PSEA endorsement for the past couple of elections, he's been giving about \$10,000 per candidate. There seems to be a connection between Jason Miller, those \$10,000, and which candidates they go to. I didn't get it

It's fine. I thought most of you guys gave like \$1,500, you know. Who would have thought it? But back to the point, there is a little connection there. There is a Daniela Andrade who also happens to be here in the audience, married to our now Chief of Human Resources Officer, appointed by particular board members. Which last meeting also said that, oh we forgot that we knew him, who also happened to be their treasurer. What a coincidence. All having come in and all happened to have those \$10,000. I ran a school board race. My budget was \$1,300 combined, raised by my own money. I don't know why you need \$10,000 for a school board race. It was noted that Ms. Vallejo and David Nelissen were the only ones on record who did not receive from that point. As far as what I know also, with little time left, I'm just curious as to what we can say. I don't know what rigamarole Trustee Campos has for us, what Trustee Stafford will say to just gloss over it, or how you, Trustee Garcia, are going to go ahead and tell me that we're the good guys, we care. So, at the end of the day, I'm just confused. How can we say we're about accountability and transparency when you didn't have cameras in the damn room? There's controversy left and right; good people are being fired. And, when two people in this room have sexual harassment. There is a Steve Campos in the room who I believe is told to have ten plus sexual harassment cases against them. And Danielle Andrade also has a history of leaking. So, you guys probably have a lot to talk about. So that's just with the time I have left. Thank you very much."

Trustee Nelissen expressed gratitude for the plaque and gavel. He also mentioned the former pass given to board members to attend sporting and district events. This was a highlight that he enjoyed very much. He also expressed gratitude for the past 12 years, acknowledging the hard work of all district staff, including principals, teachers, campus supervisors, and nutrition services workers. Trustee Nelissen mentioned seeing this dedication firsthand during campus visits, particularly at Liberty, where his daughter attends. Finally, he thanked everyone again and expressed excitement about attending more events and seeing everyone.

Trustee Vallejo suggested a new approach for Professional Development (PD) days, proposing one district-wide PD day for everyone and day two at each individual school site to address miscommunication about school-specific rules. She also suggested including a session on the District's financial budget during PD days to improve transparency and reduce misunderstandings, especially with unions.

Trustee Vallejo emphasized the importance of addressing chronic absenteeism and praised the district's attendance specialists, Marlene and Elizabeth, for their detailed work. She recommended that the Board consult with these specialists to better understand the process and improve attendance efforts.

On the topic of equity, Trustee Vallejo expressed concern about under-resourced schools, specifically Perris Lake High School. She argued that these students, many of whom face significant trauma, need more resources to match the support available at other comprehensive high schools.

Lastly, Trustee Vallejo thanked staff members who had supported her through challenging meetings, acknowledging the difficulties of navigating hidden issues and last-minute surprises. She expressed deep appreciation towards her colleagues who helped her stay grounded and focused.

Trustee Stafford thanked Trustee Nelissen and Trustee Vallejo for their service.

Trustee Campos emphasized that they have no family members working in the District, nor do they know recent hires, contrary to some social media claims. They also clarified that they had never made a political speech at a graduation, nor benefited from district-sponsored trips. He further denied rumors about complaints filed against them, stating that such claims were false and had been challenged.

Trustee Campos highlighted the importance of relationship-building on the Board, noting that while votes sometimes go in different directions, they always strive to maintain respectful, professional relationships with colleagues. He acknowledged past public attacks but expressed forgiveness toward Ms. Vallejo for her comments.

Trustee Campos shared his vision for the District, focusing on student well-being and the need for clear communication. He noted that Menifee and Perris are fortunate to have good relationships with local cities, which support the District's goals.

Trustee Campos advocated for greater investment in the arts, especially with the availability of Prop 28 funds. He emphasized the need to use these resources wisely and encouraged staff to seek out partnerships to enhance arts education across the District. Trustee Campos also mentioned the potential of the District's beautiful facilities and suggested expanding arts programs to engage students. He stressed the importance of field trips and hands-on learning and suggested creating more field trip opportunities to significant cultural sites, which would leave lasting memories for students.

Trustee Campos concluded by expressing gratitude for his time on the Board acknowledging the limited time they have left before the next election. He urged people to focus on using their time wisely, appreciating life, and being thankful for what they have. Trustee Campos ended with warm Thanksgiving wishes for all.

Trustee Garcia expressed gratitude for everyone's time, patience, and listening skills. He wished everyone a Happy Thanksgiving.
