9.2 District Update by the Superintendent

The Superintendent reported on the following:

- Superintendent Grant Bennett stated that the District is hosting a COVID Vaccination Clinic at Heritage High School that's open to the public.
- The District will be holding a COVID Vaccination Clinic on February 18th at Paloma Valley High School for all its employees.
- The Student of the Month Program was held this morning. David Gutierrez from Heritage High School will be graduating in June and will also be receiving his AA degree from Mt. San Jacinto Community College.
- The Aspiring Supervisors Academy for classified staff was held on February 6, 2021. Kirk Skorpanich, Assistant Superintendent of Human Resources, created the program for classified staff who would like to move up into supervisor positions. There were approximately 30 people in attendance.
- Student Cohorts started on February 9th at Heritage, Perris High, and Paloma Valley High School. The District is looking to bring more Cohorts in the near future.
- Perris High School hosted the Black Excellence Awards as part of Black History Month.
- On Friday, February 5th Dr. Newman and Superintendent Bennett met with approximately one dozen students from various school sites for the Student Voice. They were asked how things were going, what is currently going on with them, and what they would like to see changed as the District moves forward. The majority of students shared that the second semester is going much better in Distance Learning than the first semester.
