- Dr. Milosavljevic shared with the Board CMI's 2nd Semester Collective Commitments:
 - Graduating 100% of seniors
 - Helping all the seniors fill out FAFSA forms in addition to signing up for college or a career
 - Maintaining the highest attendance in the District
 - Maintaining the highest success rate in the District
- Senior News
 - Cohorts are meeting twice a week and receiving support
 - Six seniors are receiving a Golden Seal State Merit diploma
 - Sixteen seniors are receiving a Seal of Biliteracy diploma

- CMI had two Best Award recipients: Xitlali Trujillo for student essay and the Teacher of the Year was Ms. Jan Scibillia. This is a third win in three years for both of these individuals.
- Administration is continuing to monitor data for content areas and providing support. Most of the content areas are meeting or close to meeting the 30% goal.
- CMI held a virtual Honor Roll assembly recognizing student's accomplishments in the following areas:

 - High School Honor Roll (3.0-3.9 GPA) - 236
 - High School Principal's Honor Roll (4.0+GPA) - 41


